### Reservations

Once you have made your reservation via phone or email it will be held for ten days. A \$1000 deposit is required within ten days for a single stateroom reservation double occupancy. The charter document agreement must be mailed to us with your deposit check to keep your reservation. Once your deposit and the charter agreement are received you will be mailed your written conformation letter. On January 20<sup>th</sup> 50% of the total reservation price is due. Final payment is due by March 15<sup>th</sup> of the year traveling. Reservations made within 90 days of departure require full payment within 10 days of booking. A deposit as well as a signed charter document is required to confirm your reservation. There are no exceptions. The charter document is a written acknowledgment of Alaska Sea Adventures refund and cancellation policies.

Payments can be made by personal check, money order, certified cashier's check, or bank wire. *Please identify all payments clearly with your name, address and trip dates. All payments must be in US Dollars.*

If you find it necessary to cancel your trip, please notify us as soon as possible. You may telephone but we will need written notification via certified mail.

## **Cancellations Terms**

Initial deposit is non refundable.

All cancellations after January 20th will be subject to a cancellation fee of 50% of the total ticket price.

Cancellations received less than ninety days prior to the day of departure are not refundable and will be charged 100% of ticket price.

In the unlikely event Alaskan Dream Ventures has to cancel your cruise we will refund 100% of what you paid to Alaskan Dream Ventures. In no event, however, shall our liability exceed the obligation to refund the amount you paid to us. Alaskan Dream Ventures reserves the right to change or substitute crew members or make changes in our schedule or itinerary when necessary for the safety of our guests. In the unlikely event of mechanical breakdown, we reserve the right to make a timely substitution to another boat of comparable size and quality. If your charter is canceled or length reduced due to mechanical breakdown, we will refund the amount paid to us on a prorated basis. Alaskan Dream Ventures reserves the right to cancel any charter at any time.

#### Insurance
